The executive committee would like to see reference made to the special contribution so that it will not be confused with regular union dues. The association will take the measures that are needed to find a solution. The sector directors are invited to bring this matter up at the board committee as well.

Minutes 0102CEPV-10: Point 13. The NQTA Website. Larry Imbeault has contacted a number of companies for tenders regarding the NQTA Website; after evaluating them, the executive committee has retained the services of the CSQ. The construction of the site has begun and will be completed over the coming months.

Minutes 0102CEPV-10: Point 14. Translation of written documents. A notice was sent to the communities in May 2002 in order to find members who might be interested in translating the association's documents on a voluntary basis. The executive committee did not receive any offers.

- **Point 6. Budget.** Marcel Duplessis recounts the difficulties that the school boards have had regarding the notification of the special contribution for membership defence on the pay slips. The committee discusses the various ways that this could be indicated on the members' pay slips. The sector directors are invited to discuss the matter at the labour relations committees and the board committees.
- **Minutes 0203CEPV–01: Secretariat.** Jenny Thibault discusses the sending of summaries of the meetings. She states that it would be more efficient to write up the minutes quickly than it would be to write up summaries after each meeting.
- **Point 8. Priorities.** The committee of executive committee members set up in order to attain objective 1.2 of the document entitled *Priorities*, which was adopted at the 2000 congress in Montreal, will soon establish its procedures.
- **Point 9. Negotiations—support staff employees.** This point is on the agenda.
- **Point 10. Negotiations—teachers.** Marcel Duplessis will do the follow-up needed to inform the FSE that the sector directors will be at the bargaining tables and that the names of the teachers will be communicated to them at a later date.

Marcel Duplessis has contacted the school boards regarding the committee created by the agreement on the retention premium. The school boards are open to a preliminary meeting with the NQTA.

- **Point 11. Agreement on the alternative education program.** Marcel Duplessis explains the problems with the agreement on the alternative education program that the Cree School Board has proposed. A follow-up with the school board will take place.
- **Point 12. Professional order.** The NQTA has sent the schools a document with information on the question.
- **Point 14. Application of the collective agreement.** A note has been sent to the communities informing the members of the procedure for communicating with the NQTA.

Point 15. Sector life. No members have responded to the posting by sending candidacies for the position of director, Cree sector—support staff employees. During the union training session in Val d'Or, Barbara Zephyrine had also asked the members of the sector council for support staff employees to find out if in their workplaces there were any members interested in the position.

Point 17. Budget.

- a) The school board has accepted the request for a union leave of approximately 20 per cent for Jean Picard. The school board must now put it in place.
- b) Finance committee: the position has been filled.
- c) Accommodations: Harry Antoine will provide information under the agenda point on the budget. The changes to the reimbursement policy are the subject of another agenda point.

Marcel Duplessis will send a letter to the communities in order to explain the NQTA's structure and operations to the new members.

8. Secretariat

Jenny Thibault suggests that the executive committee adopt some minutes by telephone conference in order to reduce the amount of time required to get the information to the communities.

8.1 Congress

Jenny Thibault remarks that the next NQTA congress will take place in 2004. In order to reduce certain costs (union leaves) related to this event, it would be worthwhile to ask the Cree and Kativik school boards to set a Friday and a Monday of the same weekend during the same school year as holidays on all school calendars, as stipulated by the collective agreements for teachers, in order to allow the congress to be held.

9. Mandates of executive committee members

Marcel Duplessis explains the reasons that lead him to obtain, in writing and under his exclusive supervision, a detailed description of future union activities in which Alain Lajoie will be participating. In order to understand the matter, members of the executive committee ask questions of those concerned. Marcel Duplessis and Alain Lajoie leave the room during the discussion.

After considering the matter, the executive committee states that a lack of evidence makes it unable to deliver to a clear decision regarding the bad faith on the part of the respondent; however, the executive committee states that the errors committed by the respondent make it unable to show him its full confidence.

The executive committee explains that no further errors of the same nature will be tolerated, and that any recurrences will lead it to ask that Alain Lajoie submit his resignation. Furthermore, the executive committee upholds the decision of the president with regard to obtaining the details of future union activities in which Alain Lajoie will be participating.

10. Budget

Harry Antoine provides executive committee members with the financial statements.

Having studied the question of accommodations, he states that the Roberval Hotel presently offers the best nightly rates. The range and quality of the hotel's services must still be verified if the NQTA is to use it when putting up members attending future union activities in Montreal.

10.1 Finance committee

Harry Antoine explains the results to the work to date. A telephone conference took place involving each of the members, who are to produce reports on the committee's objectives. Another telephone conference will take place next Tuesday to determine orientations and to define the duties of each member.

11. Reimbursement policy

The members of the executive committee are given copies of a draft policy on reimbursement, which will be discussed during the next meeting in Montreal.

12. Negotiations

Proposals on the dates for tabling demands were adopted by the General Negotiation Council at its most recent meeting.

1st tabling: Major principles, planned for March 2003.

Final tabling: June 2003.

 taken the recommendations of the union group into account during the
 consultation process.
- A member who would like to retire wants to attend a conference on the subject in order to obtain more information. Jean Picard asks whether it would be possible to reply to the request during the Christmas break.
- A number of members are having problems with the retention premium; he has asked the union delegates to send him the names of those teachers.
- He appreciates the way the union advisors and the sector directors cooperate to enter grievances on the arbitration role.
- He would like to know the procedure that should be followed when a teacher requests a sabbatical leave with deferred salary.
- He presents the recommendations of the sector council, in particular those regarding negotiations.
- He would like to receive the minutes of the commissioners meetings and the seniority list of the members.
- Board committee (4–5 December 2003): He reports on the massive agenda tabled by the union group. He also asks Marcel Duplessis to provide him with policies on the organization of services for students with handicaps and students with social maladjustments or learning disabilities.

Larry Imbeault, Director, Inuit Sector—Support staff employees

The labour relations committee will meet on 15 December 2002.

 Support staff employees outside Puvirnituq and Montreal were certified on 27 November 2002. Larry Imbeault will be looking after follow-up. Larry Imbeault and Marcel Duplessis welcome the new group to the NQTA.

- The Kativik School Board issued a note on the pay slips concerning the special contribution for members' rights defence (in French: pay period 18; in English: pay period 19).

11.3 Teachers—Inuit sector

- Sick-leave days: Jean Picard explains the problem of medical appointments. He is trying to find a solution to it.
- Housing policy: it appears to the NQTA that the recommendations contained in its document of more than ten pages did not lead the school board to change its draft housing policy. A meeting with the school board is planned to try to resolve the impasse.
- Jean Picard explains that he has read all of the grievances that have been accumulating over the years; there are 115 of them. He is developing a classification system for grievances that will allow them to be prioritised according to specific criteria. The evaluation reveals that the association could withdraw about thirty of them.
- A number of members are experiencing problems with the retention premium. Jean Picard has asked the delegates to send him their lists of the teachers affected; to date, four communities have replied.
- Students with handicaps and students with social maladjustments or learning disabilities: a meeting of the union members of the committee is scheduled for 18–20 February.
- Jean Picard, Jenny Thibault, and Nelson Lamoureux are scheduled to meet on 17 February in order to propose recommendations to the school board on the teaching manual entitled *Enseigner au Nunavik* (teaching in Nunavik).

11.4 Teachers—Cree sector

- The board committee met on 4–5 February.
- A number of teachers are experiencing problems with their pay.
- Many teachers have housing problems. The school board has not completed its housing policy.
- Policy on students with handicaps and students with social maladjustments or learning disabilities: the working committee will propose a new policy soon.
- Congress: although the school calendars for next year have already been determined, the school board is trying to find a solution that will accommodate the union request.
- A number of teachers have not received their contracts.
- A few teachers have experienced unfair situations regarding the provision of medical services.

12. Labour relations

Annie Roy and Stéphanie Perreault have provided a document explaining the status of all of the labour relations dossiers.

A dossier related to the members' rights defence policy is submitted to the executive committee; it requests that more information be obtained before a decision is taken.

The union advisors and the sector directors will fill out a form and discuss this with the goal of increasing the effectiveness of communications and making it possible to have a more complete portrait of all dossiers.

6.1 Congress

Jenny Thibault explains the problem regarding the directives for establishing the Kativik School Board's school calendars. School administrators received Marcel Duplessis's letter to Lana Desmarchais requesting that 19 and 22 March 2004 be granted as holidays for the congress, but not the school board's reply accepting that request. The school board did not follow the consultation process for establishing the school calendars; it is now proposing that the choice of considering these days as either holidays or pedagogical days be left to the schools. The final decision will be taken at the board committee meeting of 5–6 March.

6.2 Community pressure regarding departures for union activities

Jean Picard states that Jenny Thibault and he are still being subjected to pressure from the community regarding their departures for union activities.

Marcel Duplessis has contacted Lana Desmarchais to discuss the problem. A meeting involving representatives of the school board, of the local education committee, of the school administration, and of the NQTA will be scheduled to find solutions to it.
