#### 12. Labour Relations

Zéni Andrade introduced the item.

- No major developments since that last EC meeting;
- A regulation is being finalized in the case of a KSB teacher (dismissal, CLP);
- There was a meeting with the CSB on July 7, to discuss the settlement of several cases. The CSB was disappointed, wanting a settlement of all cases. They were told that steps had been taken but were not successful;
- We had a settlement offer last Friday in the case of a CSB teacher. The CSB requires that the teacher receive training, in which he must pay half the cost, during the suspension period;
- There was a hearing today in the cases of two CSB support staff members. This
  is why Emma Dallas and Eve-Lyne Fecteau are absent;
- There will be a hearing next week in the case of another CSB support staff member;
- The Association has received many communications from CSB support staff members, but none from KSB support staff members;
- CSB teaching staff members have many questions about the workload;
- KSB teaching staff members have many questions about provisions for maternity leave;
- The Association has made a fixing application for 10 cases.

Council staff recommendations have been submitted so that EC members can ask questions.

# **Proposal 10**

It was moved by Patrick D'Astous and seconded by Tarek Khazen

THAT Following the union advisors' recommendation about the settlement offer by the Cree School Board to settle many cases, the Association rejects the settlement offer as proposed and mandates advisors to try and find another arrangement within the parameters of the legal opinion to achieve the same result without incurring legal consequences for the AENQ.

#### 13. Sector Life

# 13.1 KSB Support Staff

Vincent Renaud introduced the item.

- There is no union delegate in Ivujivik and Akulivik. In Puvirnituq and in Salluit there is only one delegate. There is no delegate at Jaanimmarik School in Kuujjuaq;
- There will be a LRC (Labour Relations Committee) on September 19, in Ville Saint-Laurent. A Union Advisor will join the Association's representatives despite the KSB's reluctance.

#### 13.2 KSB Teachers

Daniel Charest introduced the item.

- Two communications were sent on September 2 and September 11. Emphasis
  was on delegate elections and school committees. Members were advised to go
  through their union delegate instead of communicating directly with union
  advisors;
- The situation is difficult in Aupaluk due to the school fire that happened last year. Non-teaching time can be done at home;
- A problem was solved in a community's school committee;
- Two teachers have water-related problems (supply, broken water pipe);
- Two teachers have problems in their homes, they can't sleep due to proximity to a river:
- Problems related to directions which require teachers to tell students to leave (periods, schedules);
- Implementation of a pilot project related to a culturally-adapted calendar has caused certain problems.

## 13.3 CSB Teachers

Tarek Khazen introduced the item.

- The CSB wanted to transfer (interchange) two teachers in the adult sector from one community to another but finally changed its mind;
- Four teachers from the adult sector were not rehired due to a drop in the number of students:
- Teachers in some communities are complaining they are working in construction sites because the CSB is enlarging some schools;
- Management and the president met teachers in Mistissini because of the school principal;
- The CSB has imposed two substitute teaching periods during their non-teaching time. Teachers were advised that this could be done as part of their workload;
- The joint EHDAA Committee will be re-launched.

# 11. FSE and FPSS Equalization

FPSS: The CF-FPSS has allocated an amount of \$55,000 to its equalization fund for 2014-2015, which is a lot more than in previous years. This amount was justified by the arrival of a new union that covers a large territory (Eastern Shores) and the potential arrival of the union from the Saguenay region. The FPSS equalization fund is used to help unions send delegates to its proceedings. This year we received a reimbursement of more than \$10,000: 100% of the cost of Vincent Renaud's plane fare, while only 35% of Christine Coonishish's travel expenses were reimbursed because she travelled by car.

FSE: During the June 2014 CF, the AENQ tried to adopt a proposal so a study be conducted by an independent firm to examine the evolution of the Association's workforce within the federation since the 16% allocation level was determined in 1992, versus changes in the equalization allowance that is actually paid to the Association. This proposal was referred to the EC-FSE which has not seen fit to follow up on it. A meeting of the equalization fund grantees was held on December 3. They were presented with a modification project of the FSE's Equalization Fund Rules. The proposal that was referred to the EC-FSE was not part of it. It is now almost impossible to present new proposals to the FSE' CFI and EC so that they can recommend them to the next CF.

- GVC is used less and less;

Alain Lajoie introduced the item.

## 3. Follow-Up on the Decisions

Larry Imbeault introduced the item.

- The President and the Vice-President will be covered by a short-term salary insurance as of July 1<sup>st</sup>;
- The President is still waiting for an advice on taxable benefits in regards to travel claims;
- The policy on participation to training session on preparation of retirement is still not completed;
- The contract with Hotel Delta has been signed;
- Following the reception of tenders, an agreement was concluded with the CSQ for the construction of a wall to close the VP's office;
- The other items are on the agenda.

#### 4. Sector Life

## 4.1 KSB Support Staff

Vincent Renaud introduced the item.

- LRC: follow-up on files, Larry Imbeault is leaving the LRC, we will have to find two representatives;
- On June 3<sup>rd</sup> there was a sector council meeting by phone that lasted 2 hours. Many participants. It is very encouraging in the context of the consolidation. There will be sector council meeting right after the elections at the beginning of the next school year;
- There was an arbitration session on June 18 on the grievance of the IT, principal class.

#### 4.2 KSB Teachers

Daniel Charest introduced the item.

- Michèle Bertol, director of material resources, is conducting a consultation on the housing policy following few amendments. Natasha MacDonald, HR Director, confirmed that the Board is giving its consent for an Orientation Book following the AENQ's recommendation at the Board Committee;
- Ivujivik: a teacher points out that the UQAT could give training in the area without any consultation with the teachers. Another teacher encounters problems with the management and the union delegates (attitude);
- Inukjuak: A teacher on maternity leave informs us that she encounters problem with KSB in regards with some payments;
- Kangiqsujuaq: a teacher is contesting her position attribution in link with competencies (managerial rights). She sent a letter to the board following the suggestion of Daniel Charest in regards with waste water problems that have been ongoing for months;
- Salluit:a teacher encounters problems with the distribution of housing;
- Quaqtaq: a teachers had questions about pay cuts;

- Kangiqsualujjuaq: a teacher informs us about many problems encountered following renovations done to the dwellings during the summer (access problems);
- Kangirsuk: there are problems of availability at the daycare center in the community. A teacher is complaining about waste water problems and with the floating ped days;
- Puvirnituq: 30 students have been suspended. The Board closed a school for 3 days. Education Services has sent out resources to help the staff (Code of Life).

#### 4.3 CSB Teachers

Tarek Khazen introduced the item.

- There was a Sector Council meeting by phone of May 21<sup>st</sup>, 2015, to discuss the amendments to the improvement policy and to the safe schools policies;
- There was a Sector Council meeting by phone of May 21<sup>st</sup>, 2015, to discuss about the negotiations. Larry Imbeault and François Beauchemin attended to present the status of the negotiations and to respond to the questions;
- A special Nego Newsletter was produced by the Association and sent to the teachers;
- The CSB will keep the NLQ teachers as long as they prove to the board that they
  passed with success the MEESR exams and that they are waiting for their
  teaching certificate.

## 4.4 CSB Support Staff

Christine Coonishish introduced the item.

- There was an LRC meeting on April 15 in Montreal;
- There was a meeting of the Sector Council on June 15;
- We encounter problems with the principal at VMS. She does salary cuts to employees without verifying their timesheets and reports absences for no valid reasons for staff that went to the hospital for medical reasons;
- Few problems with OSI, disability leave requests have been denied, mostly in Wemindji and Mistissini.

#### 4.5 CPE

Larry Imbeault introduced the item.

- On April 22 and 23, the daycare workers of Oujé-Bougoumou received the visit of Ève-Lyne Fecteau and Larry Imbeault. There were numerous questions on vacation and seniority;
- ELF: "I am trying to update the lists since then. I have talked on a regular basis with Sherry-Ann, the Director, who promised me to do it week after week. I also attempt to communicate with the new delegates, Wanda and Lorraine, to discuss this. I have sent to the Director the questions that were asked by the workers so that the issues could be settled and the questions answered. I am attempting to

communicate with them so I can receive the information requested before July 3. The daycare workers want the seniority to be calculated on the worked hours, not by the hiring date. I've told them we would agree on that. The collective agreement, by agreement, could reflect this will of both parties. After our departure, and since the departure of Carmen for school, the workers have elected new delegates: Wanda and Lorraine";

- No news form Némaska. We should think about going there;
- We had a meeting with Nil Ataogul and Simon Lavigne, from the CSQ, to plan the unionization of a CPE in Nunavik;
- As discussed with Nil Ataogul, we could think about doing consolidation activities with our daycare centers with the help of the union organization department of the CSQ.

## 5. Decision Making Bodies

Larry Imbeault, Tarek Khazen, Daniel Charest, and Vincent Renaud introduced the item.

## CCNN of April 16, 2015 in Québec City

- Status of the negotiations of the tables of the North;
- Presentation of the Status with the CPNCSK;
- Discussion over the mediation.

## CGN of April 16, 2015 in Québec City

Sectorial Negotiations:

- The employer has clarified its demand on the 50 km at the two FPPE tables so that the 50 km be changed to be the territory of the school board;
- Common table on grievances and arbitration.

**Intersectorial Negotiations:** 

- pension: the demand of the government has no common sense with the present situation, at the RREGOP committee, the government never shared their concerns;
- certified maintenance workmen: the unions' demand is to pursue the work done so far and reinstate the national committee
- Salary:
  - catching-up: according to the government, the public sector has no lateness compared with the private sector, the public sector would even have a 2.3% advantage;
  - consumer purchasing power: in most provinces, the salary did not progress as much as the CPI;
  - capacity to pay: the government has only the capacity to pay what it
    offered, the economy is not in a good state and the situation should not
    improve for the next 5 years. The government has the will to reach and
    maintain a balanced budget, does not want to increase the burden of the
    taxpayers, and to respect its debt reduction objective.

Follow-up on the March 31<sup>st</sup> symposium: the assessment has not been done yet. Coordination:

One negotiation per week;

- The Ministry of Labour has invited both the employer and the unions to discuss the mediation so that it is not used only as a prerequisite;
- Refusal from the CPN to discuss issues that should be discussed at the Centrale Table.

There was a decision taken so that the unions discuss with their members on heavy pressure tactics before the CGN of June.

## CGN of May 6, 2015 in Québec City

Intersectorial Negotiations:

- The Treasury Board wished to negotiate during the summer;
- There is a will to synchronise the sectorial and the intersectorial negotiations;
- The Treasury Board has done the compilation of the issues that should be discussed at the Centrale Table: the CGN maintains its position that those sectorial issues do not belong to the Centrale Table;

#### Certified Maintenance Workmen:

• The Treasury Board proposed to continue the discussion at sub-tables with two representatives from each component of the Common Front, the CGN agrees;

#### Pension:

- The employer has three objectives: insure the sustainability of the regime, insure the intergenerational equity, and control the cost;
- To reach these objectives, the employer wishes to reconsider the conditional indexation, have the retirees contribute, make leeway, all this according to the conjuncture;

#### Coordination:

- The other components of the Common Front were informed that we are on a reflection mode on the mediation and on the heavy pressure tactics;
- The caravan tour has been discarded by the Common Front;
- The spokesperson of the Treasury Board has the feeling the union representatives want to slow down the negotiations.

There was a decision taken to ask the Government to stop negotiating in the public arena and that the CSQ adopts, if possible within the Common front, a more aggressive communication strategy before the revision of the communication plan, and to ask the Government to negotiate in good faith.

## CG of May 13, 14, and 15, 2015, in Québec City

- Status of the situation for the renewal of the collective agreements:
- Adoption of the recommendations of booklet no. 1 for the Congress;
- Adoption of the recommendations for the amendments to the CSQ By-laws.

# CF-FSE of May 21st, 2015 (just before the CGN), in Québec City

- Common Table on grievances and arbitration:
- Addition of arbitrators to the E3 and E4 collective agreements.

## CGN of May 21 and 22, 2015, in Québec City

Intersectorial Negotiations:

 Parental Rights: explanation of the employer's demands 1) to correct the collective agreements where the words "section" and "article" do not have the same meaning than in the majority of the collective agreements 2) no additional advantages than the workers that are at work 3) to foresee a periodic adjustment mechanism 4) allocation calculated on the last 20 weeks, have they been weeks worked or not 5) to have worked at least 20 weeks before being entitled to these leaves:

- Matters of Government Interests: according to the Treasury Board, everything
  that has to do with the salary structure have to be negotiated at the Centrale
  Table (not the premiums that have to be negotiated at the sectorial tables), the
  CSQ is conducting a consultation with the federations;
- Salary: on the issue of rates out of salary scales, the employer wants to cut the salaries over three years since the salary did not increase enough;
- Certified Maintenance Workmen: both parties have convene to create a subtable, which started to meet on May 20<sup>th</sup>, the unions want that the concerned categories of employment be identified and maintain that if there is a lot of subcontracting, it is because there are not enough attraction and retention measures;
- Pension: the employer agrees to create a technical forum, which will start to work on June 5:
- Regional Disparities: the employer wants to initiate explanatory discussions on the definition of sectors and to withdraw the 8% retention premium for the workers of the North Coast; wants to define what are the attraction-retention problems, but is open to discussion (the employer does not seems to be that much focussed on abolishing the 8% premium). According to the employer, the changes made to the regional disparities should be done with reallocations since there will be no cash input. The unions reaffirm their desire to improve the situation of some communities, not to do a reform of the regional disparities chapter. According to the Treasury Board, the most compelling factors are the access to the roads network, the frequency of the means of transportation, and the access to the 5 following services 1) emergency 2) health care 3) education 4) consumers' goods 5) access to lodging. The Treasury Board is ready to make an updating of the regional disparities since it has not been done since 1979.

## Common Front Coordination / Sectorial Negotiations:

- The Treasury Board affirms that some sectorial tables want to slow down the
  negotiations and to postpone subjects to this fall; according to the unions there is
  no indication that would validate this affirmation, it is ratter the opposite: some
  tables would like to add more negotiation dates;
- There is a will on the union side to synchronise the sectorial and the intersectorial negotiations;
- The union representatives do not feel a real willingness to negotiate from the employer: no answer to union demands, lack of clarity on the employer' demands (no issues raised, cumbersomeness of the employer' demands, etc.);
- Around June 5, the requests for mediation could be sent.

#### Negotiation Strategy

 There was a decision to recommend the acceptation of the employer' demands #1, 2, 3 and 5 on parental rights, but to reject demand #4; agreement to create a space of negotiation on the salary relativity; decision was taken to the effect of having the Centrale and the federations harmonise their agreements on the essential services so that they can be deposited on June 30<sup>th</sup> like the other components of the Common Front will do; and a decision was taken so that the requests for mediation be done on June 5 or on the following days.

## CG of June 3, 2015, in Québec City (before the CGN)

The quorum was not reached, there were only discussions on:

- Bill C-377;
- The federal elections.

## CGN of June 3 and 4, 2015, in Québec City

Intersectorial Negotiations: Report from the Table

- Only one negotiation day since the last CGN that was solely on the certified maintenance workmen;
- The inter-union whish that those discussions be for the 16 categories of employment, and not on the 26 first discussed, since there are no convincing reasons to adopt attraction-retention measures for 10 categories of employment first foreseen:
- The Treasury Board is discussing attraction-retention measures that would be in premiums, with a dedicated amount;
- The issue is to determine this amount;
- According to the Treasury Board, less there will be categories of employment, the bigger the amount will be for each of them;
- Next meeting will be June 17, 2015;
- According to the Coordination, there is no need to have many more meetings to settle this issue.

## Intersectorial Negotiations: Coordination

- The first phase of the negotiations is over, i.e. each other's demands have been presented, questioned, and clarified;
- The second phase is being prepared: the sectorial tables will give clarifications on their demands, leeway for negotiations will be created;
- There seems to be confusion between what the Treasury Board says (their will to negotiate) and what is going on at the tables (not many dates, no opening for discussion, etc.);
- The Treasury Board questions the need to negotiate this summer, each sectorial table will decide if they will negotiate this summer;
- The Treasury Board is suggesting doing an assessment of the situation before the summer.

## CF-FPSS of June 9 and 10, 2015, in Laval

- Forum on the intermediate structures;
- Negotiations: coordination in the education sector, including the CCNN (Coordination Committee for the Northern Tables), and explanations of the employer's demands at the S3 table;
- Presentation of the candidates for the third vice-presidency of the CSQ.

## CF-FSE of June 10 and 11, 2015, in Montmagny

- National Negotiations: decision to adopt the strategy as presented;
- CSQ Congress: mandate is given to the EC to take position on the recommendations in the best interests of the federation.

Whereas that the consolidation of the Support Staff Sectors is a priority voted in Congress;

**Whereas** the level of union leaves granted to the Teachers' Sector Directors and the level of organisation of those sectors;

Larry Imbeault moved, Daniel Charest seconded

- THAT The Support Staff Sector Directors be granted a 20% union leave, or its equivalent, from September 1<sup>st</sup> to November 30<sup>th</sup> 2015;
- THAT Those leaves be exclusively for the consolidation of the support staff sectors, to the accomplishment of the mandates foreseen in the By-laws and any other mandates given by the Executive Committee;
- THAT An assessment be done at the beginning of November, and following this assessment, a proposal be done to extend or not those union leaves.
